28 EMERGENCY AND RELIEF PROGRAM: The program provides emergency relief to community members in times of sadness, such as sickness and decease. It also provides support for other Indonesian organization that helps Indonesians. The program supported 4 community members and 2 Indonesian organizations. The organization sends aid to Indonesia in the time of disaster to Dompot Dhuafa network in Indonesia. The organization also sent aid to Mexico after the major earthquake in the country in collaboration with Indonesian embassy in Mexico City and Indonesian community in Mexico. The program delivered 100 packages in shelters, give a donation to a disabled family, and supported a mosque in Mexico City. As to Sacrifice Qurbani, The program sent meats for 30 families in Philadelphia and 500 families in Indonesia.

SCHOLAR PROGRAM AND DAYA CENTER PROGRAM: Scholar(Dakwah) program is an effort to educate Indonesian Muslim community in the U.S. The organization invited an Islamic scholar from Indonesia to educate Indonesians in Philadelphia-PA, Pittsburgh-PA, Silver Spring-Maryland, Washington-DC, Phoenix-AZ, Chicago-IL, etc. More than 500 Indonesian Muslims in the U.S. benefited the program. The DAYA Center program is a community learning center in South Philadelphia. Currently, it has Islamic Saturday School, ESL classes, Folk-Arts classes, College Preparation class, and workshops for residents of South Philadelphia. In 2017 we served about 100 beneficiaries.
